

**RESOLUTION NO. 21-09-82**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, APPROVING THE PURCHASE  
OF A 2022 FREIGHTLINER M2 DUMP TRUCK FOR THE VILLAGE  
PUBLIC WORKS DEPARTMENT FROM SBL BROWARD  
FREIGHTLINER BY PIGGYBACKING THE FLORIDA SHERIFF'S  
ASSOCIATION CONTRACT NO. FSA20-VEH18.0; AUTHORIZING  
THE VILLAGE MANAGER TO EXECUTE NECESSARY DOCUMENTS;  
AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED  
FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Islamorada, Village of Islands (the "Village") needs to purchase a new dump truck for the Village Public Works Department to replace a current 2002 Ford F650 medium duty dump truck, which is no longer reliable due to its age, excessive repairs and diminished reliability; and

**WHEREAS**, \$135,000.00 was included within the Village's adopted FY 2020-2021 Capital Projects Fund budget for the purchase of a new medium duty dump truck for the Public Works Department; and

**WHEREAS**, the Village desires to piggyback and utilize the Florida Sheriff's Association Contract #FSA20-VEH18.0 and accept the competitive bid submitted by SBL Broward Freightliner in response thereto for the purchase of 2022 Freightliner M2 Medium Duty Dump Truck for use by the Public Works Department; and

**WHEREAS**, the Village Council desires to approve the purchase of the 2022 Freightliner M2 Dump Truck from SBL Broward Freightliner at a cost not to exceed the prices set forth in Exhibit "A" attached hereto; and

**WHEREAS**, the Village Council finds that the purchase of the 2022 Freightliner M2 Medium Duty Dump Truck for the Public Works Department is in the best interest of the Village.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Approval of Piggyback Purchase.** The Village Council hereby approves the piggyback of the Florida Sheriff's Association Contract #FSA20-VEH18.0 and accepts the bid submitted by SBL Broward Freightliner for the purchase of a 2022 Freightliner M2 Dump Truck for the Village Public Works Department, at a cost not to exceed One Hundred and Twenty-Five Thousand Eight hundred and Sixty-five dollars with no cents (\$125,865.00) as set forth in Exhibit "A" attached hereto.

**Section 3. Authorization of Village Officials.** The Village Manager and/or his designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the purchase.

**Section 4. Execution of Documents.** The Village Manager and the Village Attorney are hereby authorized to execute any required documents on behalf of the Village and authorized to implement the terms and conditions of any documents necessary to effectuate the purchase.

**Section 5. Authorization of Fund Expenditure.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds for the purchase.

**Section 6. Effective Date.** This Resolution shall take effect immediately upon adoption.
