

RESOLUTION NO. 22-07-64

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, ACCEPTING THE AUDIT AND ANNUAL COMPREHENSIVE FINANCIAL REPORT FOR THE FISCAL YEAR FY 20-21 ENDING SEPTEMBER 30, 2021; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Chapter 281.39 of the Florida Statutes requires that an independent certified public accountant audit the annual financial statements of municipalities; and

WHEREAS, the Comprehensive Annual Finance Report for Islamorada, Village of Islands (the "Village") for fiscal year FY 20-21 ending September 30, 2021, was prepared in accordance with Governmental Accountant Standards Board (GASB) standards; and

WHEREAS, the audit requirement of the financial statements has been met and the report of independent auditors engaged by Village, Mauldin & Jenkins, LLC, was completed on June 29, 2022; and

WHEREAS, the Village Council hereby finds that acceptance of the audit and Annual Comprehensive Financial Report for the fiscal year ended September 30, 2021 (Attachment "A" hereto), is in the best interest of the Village.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. **Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

Section 2. **Audit Acceptance.** The Village Council hereby adopts the audit and Comprehensive Annual Financial Report for the year ending September 30, 2021.

Section 3. **Effective Date.** This Resolution shall be effective immediately upon adoption.
