

RESOLUTION NO. 23-09-93

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AMENDING RESOLUTION NO. 23-04-44 PERTAINING TO THE ESTABLISHMENT OF AN AUDITOR SELECTION COMMITTEE; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, at its meeting on April 13, 2023, the Village Council adopted Resolution No. 23-04-44 establishing an Auditor Selection Committee (the "Committee") in accordance with the requirements of Section 218.391, Florida Statutes; and

WHEREAS, Section 3 of Resolution No. 23-04-44 relating to "Terms and Composition" states that the Committee shall be comprised of three (3) members; and

WHEREAS, at its meeting on August 17, 2023, the Village Council agreed to change the composition of the Committee to four (4) members; and

WHEREAS, the Village Council desires to amend Resolution No. 23-04-44 to increase the number of Committee members to four (4).

NOW THEREFORE BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and are incorporated herein by this reference.

Section 2. Composition of the Audit Selection Committee. The Village Council hereby amends Resolution No. 23-04-44 to increase the composition of the Committee to assist in the selection of an auditor to conduct the annual financial audit required by Section 218.39, Florida Statutes, from three (3) members to four (4) members.

Section 3. **Effective Date.** This resolution shall become effective immediately upon its adoption.
