

RESOLUTION NO. 24-06-48

**A RESOLUTION OF THE VILLAGE COUNCIL OF
ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, DECLARING
THE 2008 FORD F-350 PICK-UP TRUCK AS SURPLUS
PROPERTY; AUTHORIZING DISPOSAL OF THE ASSET; AND
PROVIDING AN EFFECTIVE DATE**

WHEREAS, Islamorada, Village of Islands (the "Village") has established a policy and enacted procedures for the disposition of surplus property owned by the Village; and

WHEREAS, the Village's 2008 Ford F-350 pick-up truck has exceeded its useful life as a Village asset and has been replaced with a new vehicle; and

WHEREAS, the Village Manager has recommended that the F-350 Pick-up Truck, which was originally purchased for \$27,368.00, be declared surplus property; and

WHEREAS, the Village Council finds that disposal of the 2008 Ford F-350 is in the best interests of the Village.

**NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

Section 1. Recitals. The above recitals are true and correct and incorporated into this Resolution by this Reference.

Section 2. Disposal of Surplus Property. The Village Council hereby declares the 2008 Ford F-350 Pick-up Truck a surplus asset and authorizes the Village Manager to dispose of the surplus vehicle. The Village Manager is authorized to take all necessary and expedient action to effectuate the disposal of the surplus vehicle through auction on GovDeals.com.

Section 3. Effective Date. This resolution shall be effective immediately upon its adoption.
