

**RESOLUTION NO. 24-08-74**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, RATIFYING PURCHASES FROM  
TENCARVA MACHINERY CO LLC FROM THE BEGINNING OF FY  
2023-2024 THROUGH JULY 17, 2024; AUTHORIZING  
ADDITIONAL PURCHASES THROUGH THE END OF FY 2023-  
2024; AUTHORIZING THE VILLAGE MANAGER TO EXPEND  
BUDGETED FUNDS; APPROVING A WAIVER OF COMPETITIVE  
BIDDING; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Tencarva is a sole source vendor that the Wastewater Department utilizes to purchase Gorman Rupp Pump supplies; and

**WHEREAS**, the Village has spent \$16,811.66 on parts purchases from Tencarva from the beginning of FY 2023-2024 through July 17, 2024, as set forth in Exhibit A attached hereto (Exhibit "A"); and

**WHEREAS**, the Village needs to purchase 2 Gorman Rupp pumps from Tencarva in the amount of \$22,757.00 as set forth in Exhibit B attached hereto (Exhibit "B"); and

**WHEREAS**, the Village estimates it may need to purchase an additional \$15,000.00 in parts and supplies from Tencarva through the remainder of FY 2023-2024, which ends on September 30, 2024; and

**WHEREAS**, pursuant to Section 2-327 of the Village's Code of Ordinances relating to the Village's purchasing guidelines, purchases of or contracts for materials, supplies, equipment, improvements, or services where the total amount expended to a single vendor in any single year is \$25,000.00 or more shall be awarded by the Village Council; and

**WHEREAS**, the Village Council of Islamorada, Village of Islands (the "Village Council") finds approval of the specific purchases in the total amount of \$22,757.00 set forth in Exhibits "B", and approval of an additional \$15,000.00 in purchases from Tencarva through fiscal year ending

September 30, 2024, and waiver of competitive bidding for the purchases are in the best interest of the Village.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,**

**VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1.** **Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2.** **Approval of Expenses.** The Village Council hereby approves and ratifies the following: 1) purchase of parts from the beginning of FY 2023-2024 through July 17, 2024, in the amount of Sixteen Thousand Eight Hundred Eleven and 66/100 Dollars (\$16,811.66); 2) purchase of two Gorman Rupp pumps totaling Twenty-two Thousand Seven Hundred Fifty-seven and 00/100 Dollars (\$22,757.00); and 3) an additional Fifteen Thousand and no/100 Dollars (\$15,000.00) in purchases of parts and other supplies from Tencarva through September 30, 2024.

**Section 3.** **Authorization of Village Officials.** The Village Manager and/or his designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of purchases.

**Section 4.** **Authorization of Fund Expenditure.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to implement the terms and conditions of the purchases.

**Section 5.** **Waiver of Competitive Bidding.** In accordance with Section 2-328(1) and (3) of the Village Code, the Village Council waives the competitive bidding provisions of the Village

Code for these purchases.

**Section 6.      Effective Date.** This Resolution shall take effect immediately upon adoption.


