

**RESOLUTION NO. 24-09-99**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, APPROVING CHANGE ORDER  
NO. 1 TO THE AGREEMENT BETWEEN ISLAMORADA, VILLAGE OF  
ISLANDS AND ASAP, INC. RELATED TO THE GREEN TURTLE  
HAMMOCK PRESERVE BASIN IMPROVEMENT PROJECT;  
AUTHORIZING THE VILLAGE OFFICIALS TO IMPLEMENT THE  
TERMS AND CONDITIONS OF CHANGE ORDER NO. 1;  
AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED  
FUNDS AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on October 24, 2024, Islamorada, Village of Islands (the "Village"), entered into an Agreement with ASAP Inc. (the "Contractor") to construct a new kayak launch, seawall, and shoreline stabilization at the Village's Green Turtle Hammock Nature Preserve; and

**WHEREAS**, Article 9 "Change to Scope of Work and Additional Work" of the Agreement provides for changes, modifications, and additions to the Agreement; and

**WHEREAS**, in August 2024 at the Village's request, the Contractor presented Village staff with a quote for Change Order #1 for additional work to complete the basin improvement project through replacement of the existing dock; and

**WHEREAS**, Change Order No. 1 provides for changes to Scope of Services to reflect the additional work and to adjust the Agreement cost; and

**WHEREAS**, the Village Council finds that approval of Change Order No. 1 to the Agreement between the Village and the Contractor is in the best interest of the Village.

**NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this Reference.

**Section 2. Approval of Change Order.** The Village Council of Islamorada, Village of

Islands, hereby approves Change Order No. 1 between the Village and the Contractor, a copy of which is attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the Village Manager and approved as to form and legality by the Village Attorney.

**Section 3. Authorization of Village Officials.** The Village Manager or designee and

the Village Attorney are authorized to take all necessary and expedient action to implement the terms and conditions of Change Order No. 1.

**Section 4. Authorization of Fund Expenditure.** Notwithstanding the limitations

imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to implement the terms and conditions of Change Order No. 1.

**Section 5. Execution of Change Order.** The Village Manager is authorized to execute

Change Order No. 1 on behalf of the Village, to execute any required agreements and/or documents to implement the terms and conditions of Change Order No. 1 and to authorize any further acts necessary to implement the terms thereof, subject to approval as to form and legality by the Village Attorney.

**Section 6. Effective Date.** This Resolution shall become effective immediately upon

its adoption.


