

RESOLUTION NO. 25-02-11

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, APPROVING AN AMENDMENT TO THE AGREEMENT WITH MONIFI TECHNOLOGY GROUP TO INCLUDE AN EXPANSION OF THE VILLAGE'S CURRENT SURVEILLANCE CAMERA SYSTEM TO INCLUDE WASTEWATER STATIONS; AUTHORIZING VILLAGE OFFICIALS TO IMPLIMENT THE TERMS AND CONDITONS FO THE AMENDMENT; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE THE AGREEMENT; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; APPROVING A WAIVER OF COMPETITIVE BIDDING; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, on February 5, 2024, the Village issued Request for Proposal (RFP) 24-04 to solicit proposals form qualified firms to complete the Surveillance Camera System Project (the "Project"); and

WHEREAS, an Evaluation Committee (the "Committee") was established to review responsive proposals to the RFP and make a recommendation to the Village Council for the selection of a Contractor to complete the Project; and

WHEREAS, the Committee reviewed the nine (9) proposals received using the selection criteria detailed in RFP 24-04 and recommended selection for the highest-ranked proposal from Monifi Technology Group, LLC ("Monifi") for the Project for an amount not to exceed Fifty Thousand Seventy Five and 00/100 Dollars (\$50,075.00) to complete the Project; and

WHEREAS, on May 7th, 2024, the Village Council approved the Surveillance Camera System Project for several Village-owned properties, including the Administrative Center, Plantation Yacht Harbor Marina, Ron Levy Aquatic Center, and Public Works area; and

WHEREAS, the Wastewater Stations have recently experienced security issues, including the theft of over \$20,000 worth of equipment; and

WHEREAS, accordingly staff have identified a critical need to expand surveillance capabilities to include the Wastewater Stations; and

WHEREAS, the Village Council finds that expansion of the current surveillance camera system to include the wastewater stations is in the best interest of the Village and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated into this Resolution by this reference.

Section 2. Approval of Amendments. The Village Council hereby approves the Amendment to the Agreement, a copy of which is attached hereto as Exhibit "A," ("Amendment") between Monifi and the Village to provide an expanded surveillance camera system, together with such non-material changes as may be acceptable to the Village Manager and approved as to form and legality by the Village Attorney.

Section 3. Authorization of Village Officials. The Village Manager and/or her designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the Amendment.

Section 4. Execution of Amendment. The Village Manager is authorized to execute the Amendment with Monifi on behalf of the Village, to execute any required documents to implement the terms and conditions of the Amendment, and to execute any additional extension and/or amendments, subject to approval as to form and legality by the Village Attorney.

Section 5. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to implement the terms and conditions of

the Amendment.

Section 6. **Waiver of Competitive Bidding.** In accordance with Section 2-328(a) and (e) of the Village Code, the Village Council waives the competitive bidding provisions of the Village Code for these purchases.


Section 7. **Effective Date.** This Resolution shall take effect immediately upon its adoption.



**FIRST AMENDMENT TO
AGREEMENT BETWEEN
ISLAMORADA, VILLAGE OF ISLANDS
AND
MONIFI TECHNOLOGY GROUP, LLC**

THIS FIRST AMENDMENT to the Agreement (the "First Amendment") is made between **MONIFI TECHNOLOGY GROUP, LLC** a Florida Limited Liability Company ("CONTRACTOR") and **ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA**, a Florida municipal corporation (the "VILLAGE").

WHEREAS, CONTRACTOR and the VILLAGE entered into a certain Agreement (the "Agreement") effective May 7, 2024; and

WHEREAS, the parties desire to enter into this First Amendment to modify the scope of work and update the corresponding pricing pursuant to Section 9.01 of the Agreement.

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth in this First Amendment, CONTRACTOR and the VILLAGE agree as follows.

Section 1. Amendments to Article II and IV of the Agreement. The Agreement is amended to replace Sections 2.01 and 4.01, with the following language:

ARTICLE II
SCOPE OF WORK

Section 2.01 CONTRACTOR shall furnish all necessary expertise, personnel, tools, materials, equipment and supervision, to perform all of the work for the Project described in the RFP, and the Proposal, a copy of which is attached hereto and specifically made a part of this Agreement as Composite Exhibit "1".

ARTICLE IV
CONTRACT PRICE, GUARANTEES AND WARRANTIES

Section 4.01 The VILLAGE hereby agrees to pay CONTRACTOR for the faithful performance of this Agreement for work completed in accordance with the Proposal attached hereto as Composite Exhibit "1", and as directed by VILLAGE. Prices for work completed by the CONTRACTOR shall be as reflected in Composite Exhibit "1". A total contract price hereto is referred to as "Contract Price" and shall not exceed **One Hundred Twenty-Five Thousand Eight Hundred Twenty and no-100 Dollars (\$125,820.00)**.

Section 2. No Further Modifications. All other terms and conditions of the existing Agreement not in conflict or superseded by this First Amendment shall remain in full force and effect as if set forth herein.

Section 3. Effective Date. This First Amendment shall be effective upon execution by all parties.
