

**RESOLUTION NO. 25-05-29**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, DECLARING THE ASSETS  
SHOWN ON EXHIBIT "A" HERETO TO BE SURPLUS PROPERTY;  
AUTHORIZING DISPOSAL OF THE PROPERTY LISTED IN  
EXHIBIT "A" HERETO IN ACCORDANCE WITH THE VILLAGE  
SURPLUS PROPERTY POLICY; AND PROVIDING AN EFFECTIVE  
DATE**

**WHEREAS**, from time to time, Islamorada, Village of Islands ("Village") possesses tangible personal property which is obsolete or the continued use of which is uneconomical and/or inefficient, or serves no useful function

**WHEREAS**, prevailing Florida law permits municipalities to dispose of certain surplus property; and

**WHEREAS**, pursuant to Resolution No. 10-01-12, the Village has established a policy and enacted procedures for the disposition of surplus property owned by the Village (the "Village Surplus Property Policy"); and

**WHEREAS**, the property described in Exhibit "A" attached hereto have exceeded their useful life as a Village asset (the "Property"); and

**WHEREAS**, the Village Manager recommends that the Property be declared surplus items and be disposed of in accordance with the Village Surplus Property Policy and applicable law; and

**WHEREAS**, the Village Council finds that disposal of the Property in accordance with the Village Surplus Property Policy and applicable law is in the best interests of the Village.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1.    Recitals.    The above recitals are true and correct and incorporated into**

this herein by this reference.

**Section 2. Declaration and Disposal of Surplus Property.** The Village Council hereby declares the Property described on Exhibit "A" as surplus assets and authorizes the Village Manager and/or his designee to take all necessary and expedient action to effectuate the disposal of the surplus property in accordance with the intent of this Resolution.

**Section 3. Effective Date.** This Resolution shall take effect immediately upon its adoption.
