

**RESOLUTION NO. 25-05-32**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, APPROVING THE FINAL RANKINGS AND RECOMMENDATIONS OF THE RFP 25-02 EVALUATION COMMITTEE FOR EMERGENCY MANAGEMENT CONSULTING SERVICES; AUTHORIZING THE VILLAGE MANAGER TO NEGOTIATE AN AGREEMENT FOR THE REQUESTED SERVICES; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on February 28, 2025, Islamorada, Village of Islands (the "Village") issued Request for Proposals ("RFP") 25-02 to solicit proposals from qualified parties to provide Emergency Management Consulting Services for the Village; and

**WHEREAS**, the Village established an RFP 25-02 Evaluation Committee (the "Committee") to review responsive proposals and make a recommendation to the Village Council for the selection of a service provider; and

**WHEREAS**, the Committee reviewed the three (3) proposals received using the selection criteria detailed in RFP 25-02 and recommends Early Alert for the requested services; and

**WHEREAS**, the Village Council finds that the selection of Early Alert for Emergency Management Consulting Services in connection with RFP 25-02 is in the best interests of the Village and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Approval of Selection.** The Village Council hereby approves the selection of Early Alert for Emergency Management Consulting Services.

**Section 3. Authorization of Village Officials.** The Village Manager and/or his designee and the Village Attorney are authorized to negotiate an agreement with Early Alert.

**Section 4. Effective Date.** This Resolution shall take effect immediately upon its adoption.
