

**RESOLUTION NO. 25-05-31**

**RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, APPROVING THE PURCHASE AND INSTALLATION OF EMERGENCY LIGHTING PACKAGE FROM SOUTH FLORIDA EMERGENCY VEHICLES FOR THE VILLAGE FIRE RESCUE DEPARTMENT; AUTHORIZING THE VILLAGE MANAGER AND VILLAGE ATTORNEY TO EXECUTE NECESSARY DOCUMENTS; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; AUTHORIZING WAIVER OF COMPETITIVE BIDDING; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Islamorada, Village of Islands (the "Village") is in need of new emergency lighting and siren package for the Village Fire Rescue Department; and

**WHEREAS**, the Village desires to waive the Village's competitive bidding requirements to purchase emergency lighting and siren package with installation for a cost not to exceed

\$46,000.00 (Exhibit "A") to help ensure consistency with the other lighting and siren packages already in use by the Village Fire Rescue Department; and

**WHEREAS**, the Village Council finds that the purchase and installation of emergency lighting and siren package for the Fire Rescue Department from South Florida Emergency Vehicles (SFLEV) is in the best interest of the Village and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals.**     The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Approval of Purchase.** The Village Council hereby approves the purchase from SFLEV for a total amount of \$46,000.00.

**Section 3. Authorization of Village Officials.** The Village Manager or his designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the purchase.

**Section 4. Execution of Documents.** The Village Manager and the Village Attorney are hereby authorized to execute any required documents on behalf of the Village and to effectuate the purchase.

**Section 5. Authorization of Fund Expenditure.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to purchase the fire equipment.

**Section 6. Waiver of Purchasing Provisions.** In accordance with Section 2-328(a) of the Village Code, the Village Council waives the purchasing provisions of the Village Code to utilize the services of SFLEV without conducting a competitive bid process.

**Section 7. Effective Date.** This Resolution shall take effect immediately upon adoption.
