

RESOLUTION NO. 25-09-82

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, RATIFYING PURCHASES FROM
KB VACUUM SOLUTIONS, LLC. THROUGH THE END OF FY 2024-
2025; AUTHORIZING THE VILLAGE MANAGER TO EXPEND
BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE**

WHEREAS, as part of development and maintenance of its central wastewater collection and transmission system, Islamorada, Village of Islands (the "Village"), utilizes KB Vacuum as a sole source provider for repair and maintenance of its pumps on a project-by-project or as-needed basis; and

WHEREAS, on September 10, 2024, the Village Council adopted Resolution 24-09-92 approving \$100,000.00 in purchases from KB Vacuum in FY 2024-2025; and

WHEREAS, from the beginning of FY 2024-2025 through June 28, 2025, the Village has paid KB Vacuum \$105,874.50 for repair and maintenance, primarily for pump replacements for the wastewater pump station, in; and

WHEREAS, pursuant to Section 2-327 of the Village's Code of Ordinances relating to the Village's purchasing guidelines, purchases of or contracts for materials, supplies, equipment, improvements, or services where the total amount expended to a single vendor in any single year is \$25,000.00 or more shall be awarded by the Village Council; and

WHEREAS, the Village Council of Islamorada, Village of Islands (the "Village Council") finds that ratification of purchases from KB Vacuum in the amount of \$5,874.50 through fiscal year ending September 30, 2025, is in the best interest of the Village.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

Section 1. Recitals. The above recitals are true and correct and incorporated

into this Resolution by this reference.

Section 2. Approval of Expenses. The Village Council hereby approves and ratifies the purchases in FY 2024-2025 through June 28, 2025 from KB Vacuum at a total cost of One Hundred and Five Thousand, Eight Hundred and Seventy Four and 50/100 (\$105,874.50) in repair and maintenance through September 30, 2025.

Section 3. Authorization of Village Officials. The Village Manager and/or his/her designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of purchases.

Section 4. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to implement the terms and conditions of the purchases.

Section 5. Effective Date. This Resolution shall take effect immediately upon adoption.


