

**RESOLUTION NO. 25-10-99**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, APPROVING FISCAL YEAR  
2025-2026 EXPENDITURES WITH MUNICIPAL EMERGENCY  
SERVICES INC., TGM MEDICAL CORPORATION, BOUNDTREE  
MEDICAL, FLORIDA KEYS EMERGENCY VEHICLE REPAIR LLC.,  
ISLAMORADA POWER, LIFE SCAN WELLNESS CENTERS,  
STRYKER FLEX FINANCIAL, ISLAND AIR, AND EARLY ALERT FOR  
THE OPERATION AND MAINTENANCE OF THE VILLAGE'S FIRE  
RESCUE AND EMERGENCY MANAGEMENT SERVICES;  
AUTHORIZING THE VILLAGE MANAGER TO EXPEND  
BUDGETED FUNDS; AUTHORIZING A WAIVER OF COMPETITIVE  
BIDDING; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, as part of development and maintenance of its Fire Rescue Services, Islamorada, Village of Islands ("Village") must make regular purchases from specialized vendors; and

**WHEREAS**, the Village relies upon Municipal Emergency Services Company, TGM Medical Corporation, Bound Tree Medical, Florida Keys Emergency Vehicle Repair LLC., Islamorada Power, Life Scan Wellness Centers, Stryker Flex Financial, Island Air and Early Alert, (collectively "Fire Rescue Vendors") for operating supplies, materials, repairs, and maintenance for the Fire Department; and

**WHEREAS**, Municipal Emergency Services Company, is a provider of parts, hose appliances, tools and bunker gear for the fire department; and

**WHEREAS**, TGM Medical Corporation is under contract to provide medical direction for the fire department; and

**WHEREAS**, Bound Tree Medical is a provider of emergency medical services supplies, narcotics and online medical training; and

**WHEREAS**, Florida Keys Emergency Vehicle Repairs LLC is the Village's contracted

provider of repairs to fire department's apparatus; and

**WHEREAS**, Islamorada Power is the Village's contractor for generator repairs and preventative maintenance services for Village's 15 generators; and

**WHEREAS**, Life Scan Wellness Centers is a reliable and timely provider of NFPA 1581 compliant physicals for combat fire department staff; and

**WHEREAS**, Stryker Flex Financial, is our contractor providing monitors, gurneys, suction units, Automatic defibrillators, stair chairs and LUCAS devices for the Village; and

**WHEREAS**, Island Air is a local, reliable, and timely provider of HVAC repairs, maintenance and replacements to the Village; and

**WHEREAS**, Early Alert is contracted emergency management service company to the Village; and

**WHEREAS**, pursuant to Section 2-327(c)(4) of the Village's Code of Ordinances, competitive bidding shall apply to purchase of or contracts for materials, supplies, equipment, improvements or services where the anticipated cost is estimated to exceed \$25,000.00 for each of the FIRE RESCUE VENDORS during Fiscal Year 2025-2026; and

**WHEREAS**, pursuant to Section 2-238 of the Village Code, the requirements of Section 2-327(c)(4) of the Village's Code of Ordinances relating to competitive bidding may be waived by the following provisions as they relate to the Fire Rescue Vendors:

(a) By the Village Council upon a documented finding that the purchase of the particular goods or services without competitive bidding is in the best interests of the Village;

(c) When only one vendor possesses the unique and singularly available

capability to meet the requirements of the solicitation, such as technical qualifications, ability to deliver at a particular time, or services from a public utility;

(e) In the event of an emergency situation which requires the immediate purchase of goods or supplies, which shall not be subject to competitive bidding; and

**WHEREAS**, the Village Council finds that approval of Fiscal Year 2025-2026 not to exceed amounts for goods and services from the Fire Rescue Vendors for operation and maintenance of the Fire Department and waiver of competitive bidding in accordance with Section 2-238 of the Village Code is in the best interest of the Village.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA,  
VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Approval of Fiscal Year Expenditures.** The Village Council hereby approves the following: (1) purchases Municipal Emergency Services Company, in an amount not to exceed Seventy Thousand Dollars (\$70,000.00); (2) purchases from TGM Medical Corporation, in an amount not to exceed Eighty Four Thousand Dollars (\$84,000.00); (3) purchases from Bound Tree Medical in an amount not to exceed Fifty Thousand Dollars (\$50,000.00); (4) purchases from Florida Keys Emergency Vehicle Repairs LLC, in an amount not to exceed One Hundred Twenty Thousand Dollars (\$120,000.00); (5) purchases from Islamorada Power, in an amount not to exceed Forty Thousand Dollars (\$40,000.00); (6) purchases from Life Scan Wellness Centers, in an amount not to exceed Thirty Five Thousand Dollars (\$35,000.00); (7) purchases from Stryker Flex Financial in an amount not to exceed One Hundred Ninety

Thousand Ten Dollars (\$190,010.00); (8) purchases from Island Air, in the amount not to exceed Forty Thousand Dollars (\$40,000); (9) purchases from Early Alert in an amount not to exceed Seventy Thousand Dollars (\$70,000).

**Section 3.      Authorization of Fund Expenditure.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to implement the terms and conditions of the purchases.

**Section 4.      Approval of Waiver of Competitive Bidding.** In accordance with Section 2-238(a), (c), and (e) of the Village Code, the Village Council waives the competitive bidding provisions of the Village Code to utilize the Fire Rescue Vendors for these purchases, as applicable.

**Section 5.      Effective Date.** This Resolution shall take effect immediately upon adoption.
