

**RESOLUTION NO. 18-11-121**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AMENDING RESOLUTION NO. 18-05-43; AMENDING THE VILLAGE'S BUDGET FOR FISCAL YEAR 2017-2018; AND PROVIDING AN EFFECTIVE DATE**

**WHEREAS**, in accordance with Section 200.065, Florida Statutes and Section 6 of the Village Charter, the Village Council of Islamorada, Village of Islands (the "Village") adopted a Budget for Fiscal Year 2017-2018 by adoption of Resolution No. 17-10-78 on October 5, 2017; and

**WHEREAS**, the Village Council adopted Resolution No. 18-05-43 on May 24, 2018 to amend the Fiscal Year 2016-2018 Budget; and

**WHEREAS**, in accordance with Section 166.241 Florida Statutes, the Village Council may, within sixty (60) days following the end of a fiscal year, amend the budget for that year; and

**WHEREAS**, pursuant to Section 6 of Resolution No. 17-10-78, the Village Manager is authorized to propose a resolution to amend the budget to reallocate department, category or line item budget allocations.

**NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1.**     **Recitals.** The above recitals are true and correct and incorporated into this Resolution by this Reference.

**Section 2.**     **Budget Amendment.** In accordance with Section (6)(3) of the Village Charter and Section 6 of Resolution No. 17-10-78, the Village Council hereby approves the amendment to the Budget adopted as Exhibit 'A' of Resolution No. 18-05-43 for Fiscal Year 2017-2018 as shown on Exhibit 'A' attached hereto.

**Section 3. Effective Date.** This Resolution shall become effective immediately upon its adoption.


