

**RESOLUTION NO. 18-11-114**

**A RESOLUTION OF THE VILLAGE COUNCIL OF  
ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA,  
DETERMINING THE VEHICLES SHOWN ON EXHIBIT  
“A” TO BE SURPLUS; DIRECTING THE METHOD OF  
DISPOSITION FOR THE SURPLUS VEHICLE; AND  
PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Islamorada, Village of Islands (the “Village”) has established a policy and enacted procedures for the disposition of surplus property owned by the Village; and

**WHEREAS**, the vehicles described on Exhibit “A” attached hereto have exceeded their useful life as a Village asset; and

**WHEREAS**, the Village Manager is recommending that the vehicles be deemed surplus items and be disposed of; and

**WHEREAS**, the Village Council of Islamorada, Village of Islands (the “Village Council”) finds that disposal of the vehicles described on Exhibit “A” is in the best interests of the Village.

**NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF  
ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1.    Recitals.**    The above recitals are true and correct and are incorporated herein by this reference.

**Section 2.    Disposal of Surplus Property.** The Village Council hereby declares the vehicles described on Exhibit “A” as surplus assets and hereby authorizes the Village Manager and/or his designee to take all necessary and expedient action to effectuate the disposal of the surplus vehicles in accordance with the intent of this Resolution.

**Section 3.      Effective Date.** This resolution shall be effective immediately upon its adoption.
