

RESOLUTION NO. 18-05-44

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, PIGGYBACKING THE POLK COUNTY BID NO. 16-018 AND APPROVING THE PURCHASE OF A 2019 FREIGHTLINER M2 CUSTOM TYPE I AMBULANCE FROM ORLANDO FREIGHTLINER, INC. FOR THE VILLAGE FIRE RESCUE DEPARTMENT; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE NECESSARY DOCUMENTS; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; APPROVING A BUDGET AMENDMENT; PROVIDING FOR A WAIVER OF COMPETITIVE BIDDING; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Islamorada, Village of Islands (the “Village”) is in need of a new rescue ambulance vehicle for the Village Fire Rescue Department; and

WHEREAS, the purchase of a new rescue vehicle for the Village’s Fire Rescue Department was budgeted for in the adopted FY 2017-2018 Capital Projects Fund Budget; and

WHEREAS, the Village desires to waive competitive bidding by piggybacking the Polk County Bid #16-018 and accepting the competitive bid submitted by Orlando Freightliner, Inc. in response thereto for the purchase of a 2019 Freightliner M2 Custom Type I Ambulance; and

WHEREAS, the Village Council desires to approve the purchase of a 2019 Freightliner M2 Custom Type I Ambulance from Orlando Freightliner, Inc. at a cost not to exceed the prices set forth in the bid letter dated May 8, 2018 and attached as Exhibit “A” hereto; and

WHEREAS, the Village Council finds that the purchase of the 2019 Freightliner M2 Custom Type I Ambulance for the Fire Rescue Department, waiver of competitive bidding and approval of a budget amendment is in the best interest of the Village and its residents.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The above recitals are true and correct and incorporated into this Resolution by this reference.

Section 2. Approval of Purchase. The Village Council hereby approves the piggyback of the Polk County Bid #16-018 and accepts the bid submitted by Orlando Freightliner, Inc. for the purchase of a 2019 Freightliner M2 Custom Type I Ambulance for the Village Fire Rescue Department, at a cost not to exceed Two Hundred Fifteen Thousand Dollars (\$215,000.00).

Section 3. Authorization of Village Officials. The Village Manager and/or his/her designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the purchase.

Section 4. Execution of Documents. The Village Manager and the Village Attorney are hereby authorized to execute any required documents on behalf of the Village and authorized to implement the terms and conditions of any documents necessary to effectuate the purchase.

Section 5. Authorization of Fund Expenditure. Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to purchase the fire equipment.

Section 6. Waiver of Competitive Bidding. In accordance with Section 2-328(2) of the Village Code, the Village Council approves the waiver of the competitive bidding purchasing provision of the Village Code for the purchase the 2019 Freightliner M2 Custom Type I Ambulance.

Section 7. Approval of Budget Amendment. The Village Council approves a budget amendment to reflect use of fund balance in the Capital Projects Fund in FY 2017-2018 for the purchase of the rescue vehicle directly and without entering into a financing arrangement.

Section 8. Effective Date. This Resolution shall take effect immediately upon adoption.


