**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS FLORIDA, APPROVING THE AWARD OF FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) FY 2018 ASSISTANCE TO FIREFIGHTERS GRANT AWARD NO. #EMW-2018-FO-04416 FOR THE PURCHASE AND INSTALLATION OF STATION EXHAUST SYSTEMS FOR THE VILLAGE FIRE DEPARTMENT; AUTHORIZING VILLAGE MANAGER AND VILLAGE OFFICIALS TO TAKE ALL NECESSARY STEPS TO FINALIZE AND IMPLEMENT THE TERMS AND CONDITIONS OF THE GRANT AGREEMENT; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE THE GRANT AGREEMENT; AUTHORIZING GRANT COST SHARE; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, on October 25, 2018, Islamorada, Village of Islands (the "Village") applied for financial assistance from the Federal Emergency Management Agency (the "FEMA") pursuant to FY 2018 Assistance to Firefighters Grant (the "AFG") Program; and

**WHEREAS**, on September 11, 2019, FEMA awarded funding to the Village through Grant Award No. EMW-2018-FO-04416 (Grant Agreement), attached hereto as Exhibit "A", for the purchase and installation of station exhaust systems; and

**WHEREAS**, in accordance with the FY 2018 AFG Program Guidelines, the approved project cost in the amount of \$124,258.00 includes a ninety-five percent (95%) Federal share of \$118,340.95 and a mandatory five percent (5%) cost share by the Village of \$5,917.05; and

**WHEREAS**, the Village Council desires to approve the Grant Agreement to purchase and install the station exhaust systems.

**NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The foregoing Recitals are true and correct and are incorporated herein by this reference.

**Section 2. Approval of Grant Agreement.** The Village Council hereby approves Grant Agreement between Islamorada, Village of Islands and FEMA for the purchase and installation of station exhaust systems, attached hereto as Exhibit "A", together with such non-material changes as may be acceptable to the Village Manager and approved as to form and legality by the Village Attorney.

**Section 3. Authorization of Village Officials.** The Village Manager and Village Attorney are authorized to take all steps necessary to finalize and implement the terms and conditions of the Grant Agreement.

**Section 4. Execution of Grant Agreement.** The Village Manager is authorized to execute the Grant Agreement on behalf of the Village, to execute any related documents necessary to implement the Grant Agreement and to execute any extensions and/or amendments to the Grant Agreement subject to approval as to form and legality by the Village Attorney.

**Section 5. Approval of Grant Cost Share.** The Village Council approves the cost share commitment of five percent (5%) of the \$124,258.00 total project cost, not to exceed \$5,917.05.

**Section 6. Effective Date.** This Resolution shall take effect immediately upon adoption.

**Article 1 Assurances, Administrative Requirements, Cost Principles, Representations and Certifications**

The prohibition on disability discrimination includes the requirement that new multifamily housing with four or more dwelling units—i.e., the public and common use areas and individual apartment units (all units in buildings with elevators and ground-floor units in buildings without elevators)—be designed and constructed with certain accessible features. (See 24 C.F.R. Part 100, Subpart D)

**Article 10 Copyright**  
Recipients must affix the applicable copyright notices of 17 U.S.C. §§ 401 or 402 and an acknowledgement of U.S. Government sponsorship (including the award number) to any work first produced under federal financial assistance awards.

**Article 11 Debarment and Suspension**  
Recipients are subject to the non-procurement debarment and suspension regulations implementing Executive Orders (E.O.) 12549 and 12689, and 2 C.F.R. Part 180 as adopted by DHS at 2 C.F.R. Part 3000. These regulations restrict federal financial assistance awards, subawards, and contracts with certain parties that are debarred, suspended, or otherwise excluded from or ineligible for participation in federal assistance programs or activities.

**Article 20 Hotel and Motel Fire Safety Act of 1990**  
In accordance with Section 6 of the Hotel and Motel Fire Safety Act of 1990, 15 U.S.C. § 2225a, recipients must ensure that all conference, meeting, convention, or training space funded in whole or in part with federal funds complies with the fire prevention and control guidelines of the Federal Fire Prevention and Control Act of 1974, codified as amended at 15 U.S.C. § 2225.

**Article 21 Limited English Proficiency (Civil Rights Act of 1964, Title VI)**  
Recipients must comply with the Title VI of the Civil Rights Act of 1964 (42 U.S.C. § 2000d et seq.) prohibition against discrimination on the basis of national origin, which requires that recipients of federal financial assistance take reasonable steps to provide meaningful access to persons with limited English proficiency (LEP) to their programs and services. **Article 22 Lobbying Prohibitions**  
Recipients must comply with 31 U.S.C. § 1352, which provides that none of the funds provided under a federal financial assistance award may be expended by the recipient to pay any person to influence, or attempt to influence an officer or employee of any agency, a Member of Congress, an officer or employee of Congress, or an employee of a Member of Congress in connection with any federal action related to a federal award or contract, including any extension, continuation, renewal, amendment, or modification.

**Article 23 National Environmental Policy Act**  
Recipients must comply with the requirements of the National Environmental Policy Act of 1969, Pub. L. No. 91-190 (1970) (codified as amended at 42 U.S.C. § 4321 et seq.) (NEPA) and the Council on Environmental Quality (CEQ) Regulations for Implementing the Procedural Provisions of NEPA, which requires recipients to use all practicable means within their authority, and consistent with other essential considerations of national policy, to create and maintain conditions under which people and nature can exist in productive harmony and fulfill the social, economic, and other needs of present and future generations of Americans.

**Article 24 Nondiscrimination in Matters Pertaining to Faith-Based Organizations**
