

**RESOLUTION NO. 19-10-90**

**A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA PIGGYBACKING THE FLORIDA SHERIFF'S ASSOCIATION/FLORIDA ASSOCIATION OF COUNTIES & FLORIDA FIRE CHIEFS' ASSOCIATION AUTOMOTIVE CONTRACT NO. FSA19-VEL27.0 CHASSIS/FSA19-VEH17.0 AND APPROVING THE PURCHASE OF A 2019 FORD F250 TRUCK FROM DUVAL FORD FLEET SALES FOR THE VILLAGE FIRE RESCUE DEPARTMENT; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE NECESSARY DOCUMENTS; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE**

**WHEREAS**, Islamorada, Village of Islands (the "Village") is in need of a new vehicle for the Village Fire Rescue Department; and

**WHEREAS**, the purchase of a new truck for the Village Fire Rescue Department was budgeted for as capital outlay in the adopted FY 2019-2020 Capital Projects Fund Budget; and

**WHEREAS**, the Village desires to piggyback the Florida Sheriff's Association/Florida Association of Counties & Florida Fire Chiefs' Automotive Contract #FSA19-VEL27.0 chassis/FSA19-VEH17.0 and accept the competitive bid submitted by Duval Ford Fleet Sales in response thereto for the purchase of 2019 Ford F250 truck for the Fire Rescue Department; and

**WHEREAS**, the Village Council desires to approve the purchase of the 2019 Ford F250 truck from Duval Ford Fleet Sales at a cost not to exceed the prices set forth in Exhibit "A" attached hereto; and

**WHEREAS**, the Village Council finds that the purchase of the 2019 Ford F250 truck for the Fire Rescue Department is in the best interest of the Village and its residents.

**NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:**

**Section 1. Recitals.** The above recitals are true and correct and incorporated into this Resolution by this reference.

**Section 2. Approval of Piggyback Purchase.** The Village Council hereby approves the piggyback of the Florida Sheriff's Association/Florida Association of Counties & Florida Fire Chiefs' Automotive Contract #FSA19-VEL27.0 chassis/FSA19-VEH17.0 and accepts the bid submitted by Duval Ford Fleet Sales for the purchase of a 2019 Ford F250 truck for the Village Fire Rescue Department, at a cost not to exceed Fifty Six Thousand Six Hundred Thirty (\$56,630.00) as set forth in Exhibit "A" attached hereto.

**Section 3. Authorization of Village Officials.** The Village Manager and/or his designee and the Village Attorney are authorized to take all actions necessary to implement the terms and conditions of the purchase.

**Section 4. Execution of Documents.** The Village Manager and the Village Attorney are hereby authorized to execute any required documents on behalf of the Village and authorized to implement the terms and conditions of any documents necessary to effectuate the purchase.

**Section 5. Authorization of Fund Expenditure.** Notwithstanding the limitations imposed upon the Village Manager pursuant to the Village's Purchasing Procedures Ordinance, the Village Manager is authorized to expend budgeted funds to purchase the fire equipment.

**Section 6. Effective Date.** This Resolution shall take effect immediately upon adoption.
