

RESOLUTION NO. 19-04-23

A RESOLUTION OF THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, APPROVING THE AWARD OF 2019 GRANT FUNDS FROM THE FLORIDA FOREST SERVICE VOLUNTEER ASSISTANCE GRANT FOR THE PURCHASE OF FOUR (4) DIGITAL PORTABLE RADIOS AND ACCESSORIES FOR THE FIRE RESCUE DEPARTMENT; AUTHORIZING THE VILLAGE MANAGER TO EXECUTE THE GRANT DOCUMENTS AND TO TAKE ALL STEPS NECESSARY TO FINALIZE AND IMPLEMENT THE TERMS AND CONDITIONS OF THE GRANT AWARD AND THE PURCHASE; APPROVING AN AMENDMENT TO THE VILLAGE'S FY 18-19 BUDGET TO REFLECT THE GRANT AWARD; PROVIDING FOR A WAIVER OF COMPETITIVE BIDDING; AUTHORIZING THE VILLAGE MANAGER TO EXPEND BUDGETED FUNDS; AND PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, Islamorada, Village of Islands (the "Village") applied for a 2019 Volunteer Fire Assistance Grant (the "Grant") from the Florida Forest Service, Florida Department of Agriculture Consumer Services ("FDACS"); and

WHEREAS, the Village has been awarded Grant funds from the FDACS in the amount of Thirty-One Thousand Five Hundred Ninety-Eight Dollars (\$31,598.00) to purchase four (4) Digital Portable radios for its Fire Rescue Department (the "Grant Award"); and

WHEREAS, pursuant to the terms of the Grant Award, the Village is required to match fifty percent (50%) of the grant funds to be utilized for acquisition of the radios; and

WHEREAS, the Village Manager has recommended that the Village Council approve a budget amendment to reflect receipt of the Grant Award and provide the matching funds of Fifteen Thousand Seven Hundred Ninety-Nine Dollars (\$15,799.00); and

WHEREAS, the Village Council finds that it is in the best interests of the Village to accept the award of grant funds from the FDACS and approve the purchase of four (4) radios for the Fire Rescue Department, as set forth in the Grant Award attached hereto as Exhibit “A”.

NOW THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF ISLAMORADA, VILLAGE OF ISLANDS, FLORIDA, AS FOLLOWS:

Section 1. Recitals. The foregoing Recitals are true and correct and are incorporated herein by this reference.

Section 2. Acceptance of Grant Award. The Village Council of Islamorada, Village of Islands hereby accepts the 2019 Volunteer Fire Assistance Grant Award from the Florida Forest Service, Florida Department of Agriculture and Consumer Services, for the purchase of four (4) radios for the Fire Rescue Department.

Section 3. Authorization of Village Officials. The Village Manager is hereby authorized to execute the Grant documents, a copy of which is attached hereto as Exhibit “A”, together with such non-material changes as may be acceptable to the Village Manager and approved as to form and legality by the Village Attorney, and to take all steps necessary to finalize and implement the terms and conditions of the Grant Award and the purchase of four (4) radios from Motorola.

Section 4. Approval of Budget Amendment. The Village Council hereby approves a budget amendment to increase the FY 18-19 Capital Projects Fund revenues by Fifteen Thousand Eight Hundred Dollars (\$15,800.00), increase the Fire Rescue Capital Outlay account FY 18-19 expenditure budget by Thirty-One Thousand Six Hundred Dollars (\$31,600.00), and reflect a transfer of Fifteen Thousand Eight Hundred Dollars (\$15,800.00) from the General Fund to the Capital Projects Fund.

Section 5. Waiver of Purchasing Provisions. In accordance with Sections 2-328(1) and 2-328(3) of the Village code, the Village Council hereby approves the waiver of competitive bidding to purchase the radios from Motorola.

Section 6. Authorization of Fund Expenditures. The Village Manager is hereby authorized to expend budgeted funds for the purchase as set forth in the Agreement.

Section 7. Effective Date. This Resolution shall take effect immediately upon its adoption.
